

Classic Minutes for Dec. 13th, 2023, at 6:30 PM at Reeds Athletic Complex (4000 Old West Hwy 64 Lexington, NC 27295).

Lexington High School field will be used in the Spring 2024 season for practices and games. Northwest and Finch Park will be used this spring as well. Dates and Times of what we need are to be given to Brent/Lexington. Lights can be used. Until 2/26 4:45-6:30, after then 7-9 PM) Look at Max Prep for Lexington's games to see when the field can be used.

*Updating the Website:

1. Bios for all coaches and directors are to be added to the website. Either Rick, Jonas or Tasha will add these to the classic website.
2. Add John Blake's Soccer Resilience Company to the Resources tab.
3. Add a Sponsor tab to the website.

*Possible addition of filming games with VEO alternatives.

*Possible expansion into Rowan County. No classic soccer there.

- We will inquire with NCYSA what associations affiliated with NCYSA are currently in Rowan County and near the address of the new complex.

*Interest in co-hosting a tournament in the future with Asheboro?

- We are interested in establishing good relationships with other clubs and the Asheboro association are good people. We are interested in co-hosting a tournament. They have 6 turf fields near the zoo. Jonas will speak to them and gather a plan with their tournament board.

*Update on possible complex in Davidson County.

- There is a meeting set with Jonas and the County for 12/15/2023. Answers are needed about location/distance of associations and miles of affiliated NCYSA clubs.

*Bringing in Sponsors, all ideas welcome.
